## GEEK NEWS NOW SUBSCRIBER CONTEST

### Official Contest Rules

#### 1. How to Enter the Contest

a. The GEEK NEWS NOW SUBSCRIBER CONTEST will begin at 5 p.m. on July 6, 2020 and ending 13 July at 5 p.m. (All times are CST). After ending, three people will be randomly selected and will win an Amazon gift card. This Contest will award the Prizes described below.

b. To participate in the Contest, you may enter via the following method:

Subscribe to the GNN YouTube channel.

Subscribe to the GNN Podcasts.

Subscribe to the GNN Website.

c. One Entry per person, per media (Twitter and website) is permitted for a maximum of three entries.

#### 2. Eligibility Restrictions

a. Employees of GNN and the members of their immediate families (spouse and parents, children and siblings and their spouses) and individuals living in the same households of such employees are ineligible to win. The contest is subject to all applicable federal, state, and local laws and regulations. GNN employees may enter, but will not be eligible to win a prize.

b. GNN employees may enter, but will not be eligible to win a prize.

c. Entrants are required to provide truthful information and GNN will reject and delete any entry that it discovers to be false or fraudulent. GNN will disqualify any entry from individuals who do not meet the eligibility requirements.
