NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. How to Enter the Contest

a. Make a comment predicting the domestic and/or worldwide box office gross for the opening weekend of the movie declared by GNN to be the subject of the contest. This Contest will award the Prizes described below. Winners will be notified no later than seven (7) days after the opening weekend has elapsed.

By entering this Contest, you agree to abide by these Official Rules and acknowledge that this Contest is in no way sponsored, endorsed, or administered by or associated with Facebook.

c. One entry per person only is permitted. Any person found using multiple Facebook and/or email accounts to enter will be declared ineligible.

2. Eligibility Restrictions

a. The contest is open to all persons anywhere in the world who are 13 years of age or older and have a valid e-mail address as of December 1, 2019. Void where prohibited or restricted by law. Employees of GNN and the members of their immediate families (spouse and parents, children and siblings and their spouses) and individuals living in the same households of such employees are ineligible to win. The contest is subject to all applicable federal, state, and local laws and regulations.

b. Only one winner per household is permitted in any sweepstakes or contest administered by GNN.

c. Entrants are required to provide truthful information and GNN will reject and delete any entry that it discovers to be false or fraudulent. GNN will disqualify any entry from individuals who do

not meet the eligibility requirements, and GNN will also delete any entry received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

### 3. Prizes:

- One (1) \$20 Amazon Gift Card to be transmitted electronically to the winner's account.

a. No prize substitutions, cash equivalent, or transfer of prizes permitted except at the sole discretion of the Sponsors. Prize subject to availability and the Sponsors reserves the right, at its sole discretion, to award a prize of greater or equal value if the advertised prize is unavailable. Taxes or other expenses not mentioned above are solely the responsibility of the winner.

b. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. Sponsors are not responsible for the safe arrival of a prize or prize certificate.

c. Selection of Winners - The winners of the prizes will be selected from all eligible entries not later than seven (7) days after the opening weekend has elapsed, based on the format described by Sponsor on its website. The winner will be designated as the person whose estimate is closest to the domestic or worldwide opening weekend box office gross. The source of the declared weekend total will come from BoxOfficeMojo.com. Going over the amount does not disqualify you.

You need not be present to win. Winners will be announced on Facebook.

Each potential winner will be asked to contact GNN with a given e-mail address provided via comment on the entrant's entry. Once potential winner and GNN make e-mail contact, GNN will provide a photo for the potential winner to upload to the winner's Twitter or Facebook account in order to validate their account. Once the validation occurs, potential winner must execute and return any required affidavit of eligibility and/or liability/publicity release in which they agree to hold Sponsor, Facebook, and each of their parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives harmless against any and all claims or liability arising directly or indirectly from use or misuse of a prize or participation in the Contest. Affidavits will be mailed or emailed based on the potential winner's preference. Affidavits must be executed and returned within seven (7) days or prize will be forfeited and an alternate winner may be chosen. If a potential winner cannot be contacted, is unable to accept the Grand Prize as awarded, fails to sign and return the required affidavit of eligibility and liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, potential winner forfeits prize and it will be awarded to an alternate winner.
