Official Contest Rules

1. How to Enter the Contest

a. The GEEK NEWS NOW MARVEL WALL ART CONTEST will begin at 5 p.m. on June 1, 2020 and ending 8 June at 5 p.m. (All times are CST). After ending, two people will be randomly selected and will win a pair of prizes. This Contest will award the Prizes described below.

b. To participate in the Contest, you may enter via the following method:

Follow GNN on Twitter https://twitter.com/GNN_Home for one (1) entry. Subscribe to the website for a second entry (maximum of two entries per person). <https://geeknewsnow.net/> By entering this Contest, you agree to abide by these Official Rules.

c. One Entry per person, per media (Twitter and website) is permitted for a maximum of two entries.

2. Eligibility Restrictions

a. Employees of GNN and the members of their immediate families (spouse and parents, children and siblings and their spouses) and individuals living in the same households of such employees are ineligible to enter or win. The contest is subject to all applicable federal, state, and local laws and regulations. GNN employees may enter, but will not be eligible to win a prize.

b. Only one winner per household is permitted in any Contest administered by GNN.

c. Entrants are required to provide truthful information and GNN will reject and delete any entry that it discovers to be false or fraudulent. GNN will disqualify any entry from individuals who do not meet the eligibility requirements.

3. Prizes:

a. Four pieces of Marvel art will be the prizes for the contest, given away in pairs to the two entrants who win, selected at random. Discretion of the prize choice will be left up to a GNN representative.

- (1) Black Panther wall art, 28" tall by 9" wide, retail value \$25 USD.
- (1) Groot wall art, 13" tall by 12" wide, retail value \$25 USD.
- (1) Captain America wall art, 17.5" tall by 12" wide, retail value \$20 USD.
- (1) Captain Marvel wall art, 19" tall by 13" wide, retail value \$20 USD.

b. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. Sponsors are not responsible for the safe arrival of a prize or prize certificate.

d. Selection of Winner

Two (2) winners will be chosen at random from the number of entrants received from both the Twitter and website. Any entrant made after 5 p.m. on June 8 will not be considered.

Potential winner notification will be made as soon as possible. Once the choices are announced potential winners must execute and return any required affidavit of eligibility and/or liability/publicity release in which they agree to hold Sponsor, and each of their parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives harmless against any and all claims or liability arising directly or indirectly from use or misuse of a prize or participation in the Contest.

incomplete or late entries, telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from entering or claiming a prize.

GNN in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of GNN website, the GNN Facebook or Twitter pages or otherwise in violation of the rules. GNN further reserves the right to cancel, terminate or modify the Contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
